Personal Protective Equipment (PPE)

Applicators and other handlers must wear:

- Long-sleeved shirt and long pants
- Waterproof gloves
- Shoes plus socks

Product Information

AGRIPHAGE-NUT & STONE FRUIT is a bactericide that is comprised of a formulation of bacteriophages to be used as a preventive and curative product for the control of bacterial disease on nuts and stone fruit (*Xanthomonas arboricola* pv. *pruni*, *Xanthomonas arboricola* pv. *juglandis*, *Xanthomonas arboricola* pv. *corylina*, and *Pseudomonas syringae* pv. *syringae*).

- Apply AGRIPHAGE-NUT & STONE FRUIT as a preventive measure to protect growing leaf and fruit tissue or when conditions are conducive to heavy disease pressure, and as a curative when the first disease symptoms are visible.
- Apply AGRIPHAGE-NUT & STONE FRUIT with conventional equipment as a foliar application.

Mixing Instructions and Compatibility Information

-MIX WELL PRIOR TO USE-

ORDER OF MIXING:

1. Prior to use, remove scale, pesticide residues, and other foreign matter from the spray tank and entire application system. Flush with clean water. Failure to provide a clean spray tank may cause AGRIPHAGE-NUT & STONE FRUIT to lose effectiveness or strength.
2. Fill the spray tank with clean water and begin agitation.
3. Add the specified amount of AGRIPHAGE-NUT & STONE FRUIT.

Do not allow spray mixture to stand for more than 24 hours. Maintain a spray solution pH between 6.0 and 8.5.

GROUND TANK MIX INSTRUCTIONS: Mix 1-3 quarts of AGRIPHAGE-NUT & STONE FRUIT per acre in sufficient water to achieve thorough coverage of the crop canopy. If available, use mechanical mixing, agitation ensures proper blending.

COMPATIBILITY: Do not combine AGRIPHAGE-NUT & STONE FRUIT in the spray tank with denaturing agents, copper, or iron salts. Apply AGRIPHAGE-NUT & STONE FRUIT in approved tank mixes or in an alternating spray program. AGRIPHAGE-NUT & STONE FRUIT is compatible with several commonly used fungicides, liquid fertilizers, herbicides, and insecticides, but has not been fully evaluated with all of these. AGRIPHAGE-NUT & STONE FRUIT cannot be mixed with another product with a prohibition against mixing. Use of the tank mix must be in accordance with the more restrictive label limitations and precautions.

Application Instructions

GROUND APPLICATION

RATE	PRE-HARVEST INTERVAL (PHI)	APPLICATION
1 to 3 quarts per acre in sufficient water to achieve thorough coverage of the crop canopy.	AGRIPHAGE-NUT & STONE FRUIT may be applied up to and including the day of harvest.	Begin applications when conditions are conducive to development of disease. Repeat application every 3 to 10 days as needed, for as long as conditions favor disease development. Under light to moderate disease pressure or for smaller plants, use lower rates (1 to 2 quarts/acre). Under severe disease pressure, or when environmental conditions and plant stage are conducive to rapid disease development, use higher label rates (2 to 3 quarts/acre), and apply more frequently (every 3-7 days).

Storage and Disposal

Do not contaminate water, food, or feed by storage or disposal.

Pesticide Storage: Store this product in a cool, dry area. Direct sunlight and/or extreme heat may cause degradation of the product and decrease product efficacy.

Pesticide Disposal: Wastes resulting from the use of this product must be disposed of on site or at an approved waste disposal facility.

Container Handling: Nonrefillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank, or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then, offer for recycling if available or reconditioning if appropriate, or puncture and dispose of in a sanitary landfill or by incineration, or if allowed by state and local authorities, by burning. If burned, stay out of smoke.
